- The exhibitor fee is € 6700 (excl. VAT) for one regular unit of approx. 4,5 m<sup>2</sup> and € 13.400 for a one regular unit + a demo unit of approx. 9m2, in the joint NL booth, plus the use of a shared meeting & facility area at the booth. This fee is <u>excluding the mandatory fees</u> charged by SEMICON Europa and Messe München, being the co-exhibitor fee of € 1000,00 (non-SEMI members), € 700,00 (SEMI members) and the communication fee of € 990,00. These fees will be invoiced directly to you by SEMICON and Messe München.
- If SEMICON Europa 2025 cannot take place as a physical event in Messe München due to unforeseen circumstances, the exhibitor will contribute (pro rata) to the preparation costs already incurred by High Tech NL.
- High Tech NL rents booth space at SEMICON Europa 2025 and ensures further coordination with the co-exhibitors.
- Your company will be presented at a highly visible central place located in hall B1, booth 1533. A fully designed and built display area, NL branded, with a shared meeting & facility area with bar and extra seats and two separate meeting rooms, welcoming reception for visitors and daily network events at the booth.
- Included in participation in the pavilion are the space rent, the design and construction of the joint booth and the individual exhibitor units, complete booth organization and support, organization and catering of daily network events at the booth, project management and communications before, during and after the exhibition, and the production of a booth exhibitor online directory with company profiles.
- Please note registration at SEMICON Europa is mandatory (instructions were shared with you separately). Once registered as a co-exhibitor in the SEMICON Europa directory you will be included exhibition catalogue and its online exhibitors list.





- Not included are costs for travel and accommodation of your company's employees/representatives and (transport and insurance of) your own exhibition goods.
- The regular unit of approx. 4,5 m<sup>2</sup> consists a printed back wall, LCD screen, lockable cabinet and 3 230 Volt power supplies, to power regular equipment such as laptops and mobile phones.
- The DEMO unit of approx. 4,5 m<sup>2</sup> consists a small information pillar print, logo-sign, small high table, 2x barstool, 3 230 Volt power supplies, to power regular equipment such as laptops and mobile phones and power supplies for DEMO machines as needed. PLEASE NOTE: A demo unit can only be purchased in combination with a regular unit.

Installation of DEMO machines in consultation with High Tech NL regarding technical aspects for the construction of the stand. Specifications of the DEMO machines must be communicated to High Tech NL as soon as possible, but no later than August 1, 2025. Transport organization and transport costs from DEMO Machines to and from the assigned DEMO unit on the stand are for the exhibitor's account).

- The co-exhibitor is responsible for the timely supply of materials (logo, design, text, etc.) for prints. Instructions will be provided.
- Placement of own (roll-up) banners, panels etc. is not allowed. If there are specific wishes with
  regard to your own unit (e.g. the need for more space in connection with a large demo or renting
  extras such as display cases or brochure racks) separate agreements will be made. Availability and
  placement of additional furniture and demos is subject to the total wishes of all exhibitors and an
  optimal layout of the pavilion. High Tech NL reserves the right to make choices in order to
  maintain the open and communal character of the pavilion. Costs for any additional furniture or
  facilities are not included in the above mentioned exhibitor fee.
- High Tech NL will charge 100% of the exhibitor fee upon confirmation.
