- The exhibitor fee is **EUR 3,950** (excl. VAT) for a company unit in the joint booth, plus the use of a shared meeting & facility area at the booth.
  - This rate only applies to organisations based in the Netherlands.
  - This fee excludes the optional communication fee to appear with your own profile on the SEMICON Taiwan trade fair page.
- Optional: placement of a demo machine at the NL Pavilion, in consultation with High Tech NL. Availability is limited; this option requires the purchase of two booth units and is subject to approval in line with the pavilion design guidelines.
- If SEMICON Taiwan 2026 cannot take place as a physical event in Taipei due to unforeseen circumstances, the exhibitor will contribute (pro rata) to the preparation costs already incurred by High Tech NL.
- High Tech NL rents booth space at SEMICON Taiwan 2026 and ensures further coordination with the co-exhibitors.
- Your company will be presented at a highly visible central place. A fully designed and built display area (100m<sup>2</sup>), NL branded, with a shared meeting & facility area with bar, extra seats and daily networking events at the booth.
- Participation in the pavilion includes: space rental; design and construction of the joint booth and individual exhibitor units; support and organisation at the booth; project management and communications before, during, and after the exhibition; and the production of an online exhibitor directory with company profiles.
- Please note registration at SEMICON Taiwan is mandatory.
- Not included are costs for travel and accommodation of your company's employees/representatives and (transport and insurance of) your own exhibition goods.
- The rented booth unit consists of your logo, 1 LCD screen, a lockable cabinet and 2 power supplies. The exhibitor is responsible for the timely supply of materials (logo, company profile, etc.). Instructions will be provided.

To ensure a uniform and open pavilion design, the placement of individual banners or panels is not permitted. Specific requirements (e.g. large demos or additional display cases) can be discussed separately. High Tech NL reserves the right to make decisions in order to maintain the open and communal character of the pavilion. Costs for any additional facilities are not included in the above-mentioned exhibitor fee.

High Tech NL will charge 100% of the exhibitor fee upon confirmation. In case of cancellation after confirmation, participation fees will not be refunded
